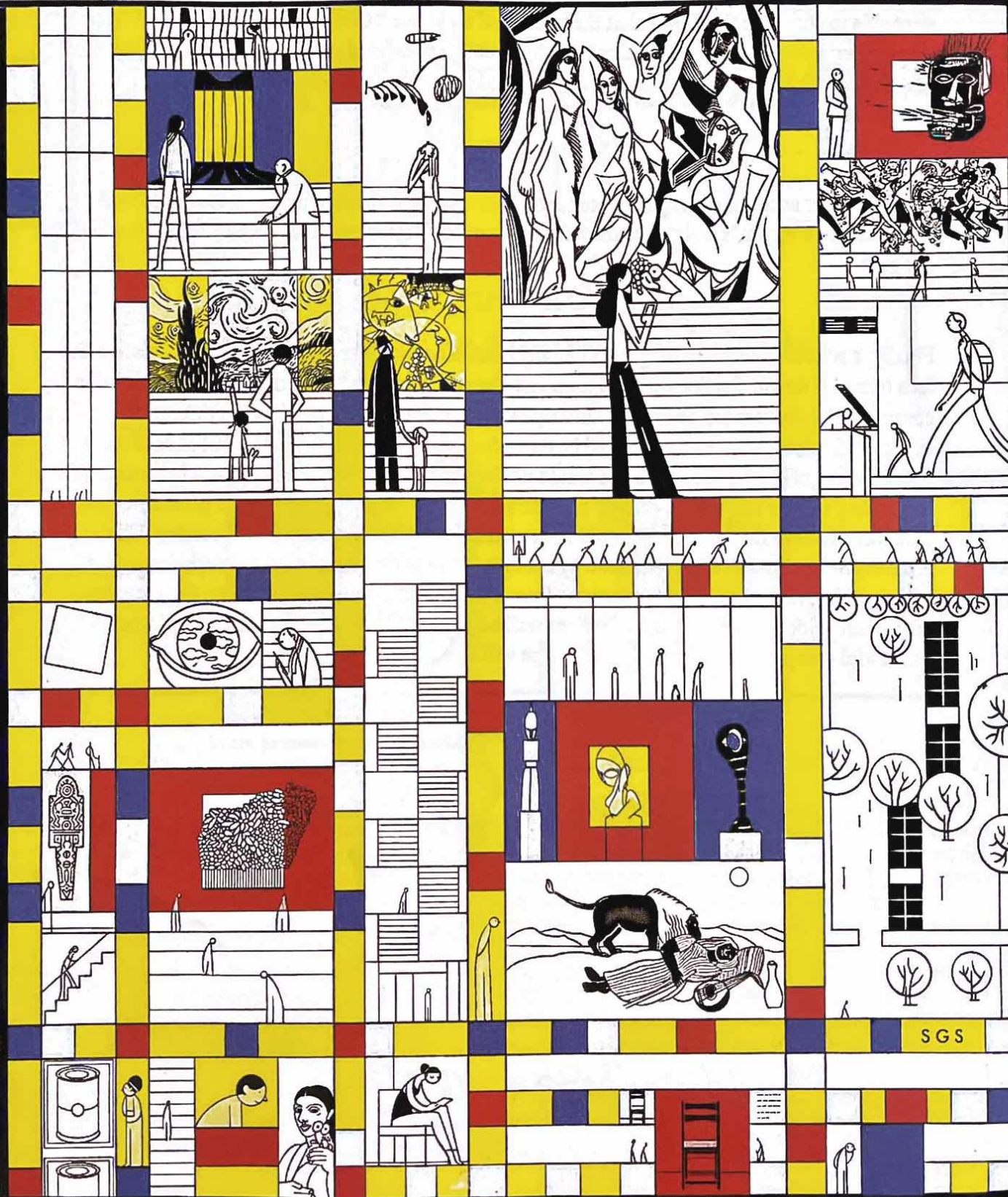

Year in Review - James H. Voyles & Jennifer Lukemeyer

Client charged with attempted murder and various other lesser charges for her putting feces in her 15-year-old son's pic-line while he was hospitalized for leukemia. This led to constant infections which, in turn, delayed the needed chemotherapy treatment. No folks - fact cannot get much worse than this. Mounting a defense of Munchausen by proxy, Voyles and Lukemeyer were able to convince the Court that the client had no active "intent to kill." Because of double jeopardy principles, the number of counts she could be convicted of were very limited. The Court sentenced her to 7 years in prison only to modified out to home detention after a year of incarceration.



Teacher client accused of groping a student's breast while providing tutoring. Despite DNA evidence and a victim's insistence the crime happened, Voyles convinced a jury otherwise for a not guilty.

Finally, a school superintendent was federally hunted down for bribery allegations and when the feds turned it down, the State picked it up and charged him with 3 counts of bribery. The bribe consisted of 2 dinners for he and his colleagues and a pair of REO Speedwagon tickets in exchange for the promise of continued business for a vendor of the school (about 11 million dollars worth of business). The State would not budge despite at the time of these luxurious gifts, the bribing vendor had no bids before or contracts with the school. The elected prosecutor in the case was adamant the nominal gifts did effectuate millions in contracts for the vendor. The elected prosecutor was also motivated by his own father having been a school superintendent who would never have accepted anything from a vendor. The personal polish on the case was more than evidence. Ultimately, the client walked away with a misdemeanor conviction of "unlawful competitive bidding" and the case will be expunged within a year.

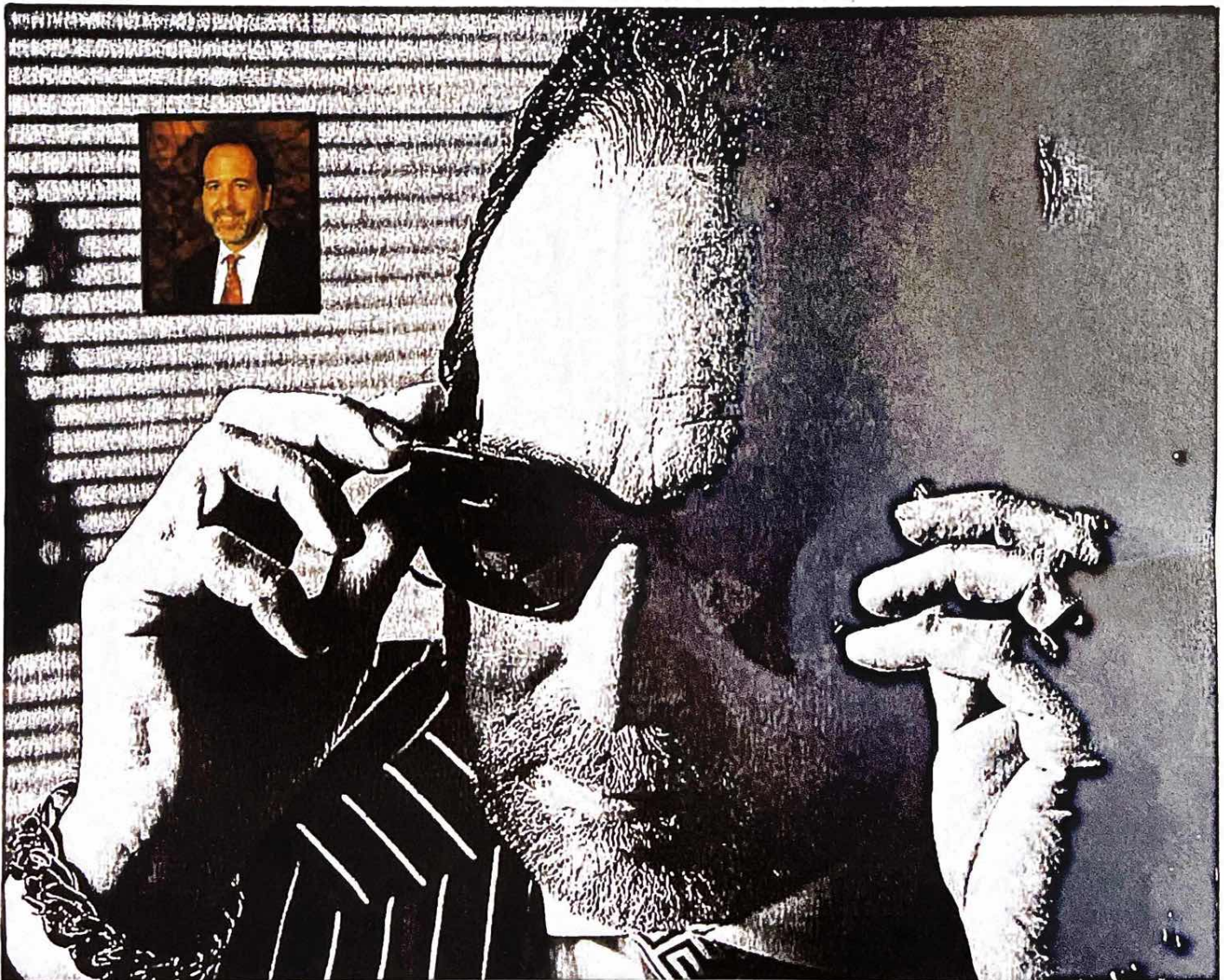
## Trump's new lawyer is famous for representing Atlanta rappers like Gucci Mane and Migos and has called the former president 'racist' and 'pathetic'
